#### How we store your personal information

Your information is securely stored.

We keep email and phone number for a period of 7 years. We will then dispose your information by shredding or destroying personal documents that show your name, address and other personal details.

#### Your data protection rights

**Your right to object to processing** - You have the right to object to the processing of your personal information in certain circumstances.

**Your right to data portability** - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
